PRIME MINISTER BOOSTS **SCHOOLS WITH £14 BILLION PACKAGE**

On Friday, 30 August, the Prime Minister announced an investment of over £14 billion in primary and secondary education between now and 2022 to 2023.

This will be discussed further at the October FIGS along with a budget update.

GET READY FOR BREXIT

The UK is leaving the EU on 31 October 2019.

The government has guaranteed that in the event of leaving the EU without a deal, all those who are resident in the UK before the UK leaves the EU will be able to stay. Employers should ensure that their employees, including apprentices, who are EU/EEA or Swiss citizens living in the UK are aware that they and their family members will need to apply for settled or pre-settled status through the EU Settlement Scheme in order to secure their rights.

If they haven't, they still have until 31 December 2020 to do so. There is a toolkit available for employers to help their employees, if required.
