Schools Budget Funding 2019-20

- Schools Budgets (issued on 28th February)
- Teachers Pay rise from September 2018 (3.5%): TPG 2.5%
 Methodology: rate X census count (October 2018)
 Rate & individual school allocations confirmed for April 2019 to March 2020.
- Teachers pay rise September 2019 (2.75%) TPG 0.75% Methodology: rate x census count (October 2018).
 Rates now confirmed and awaiting individual school allocations for Sept 2019 March 2020.
- Teachers Pension increase from September 2019:

Increase from 16.48% to 23.68%

Government have said they will fully fund

Methodology: rate X census count (October 2018).

Supplementary fund: ensure unfunded element of pensions cost is no more than 0.05% of individual schools budget. No details



Schools Budget Funding 2019-20

- Year 7 Literacy & Numeracy Catch Up grant (no details)
- Pupil premium Ever 6 FSM (E6FSM), Ever 6 Service Children (E6SC) & Post Looked After Children (PLAC). (confirmed)
- Devolved Formula Capital (published in May)
- Primary PE and Sport Premium Grant (April to August 2019 confirmed & published); (2019-20 academic year confirmed awaiting details)
- Universal Infant Free School Meals (September 2019 August 2020 initial estimates confirmed; final allocations June 2020 (updated for Jan 2020 census)
- Free School Meals Supplementary Grant (no details)



Background/Reminder School Budgets 2019-20

Funding for Schools (pre-16) is split into 4 ring-fenced blocks:

- Local Authorities have limited ability to transfer money between blocks. School Forum and possibly Secretary of State Approval
- 2018-19 Government introduced a National Funding Formula (NFF) for calculating the schools block (pre 16 funding)
- Soft NFF has been in place for 2018-19 & 2019-20 (no planned date for Hard NFF)
- Individual allocations for each school in the country were calculated and published by the ESFA for the period 2018-19, 2019-20 and when NFF fully implemented (date not stated)
- LA allocations for 2018-19 and 2019-20 were the aggregated value of the notional individual school budgets

- Kent at full National Funding Formula (NFF) rates except:
 - Factor 2 Ever 6 Free School Meals (Primary 60% & Secondary 60%)
 - Factor 6 Low Prior Attainment (Primary 71% & Secondary 77%)
 - Minimum Funding Level (Primary 97% & Secondary 98%)
 - Lump Sum (incl. Area Cost) LFF £120,083, NFF £110,076 (109%)

- A three year funding commitment for schools is very welcome
- 2020-21 includes £780m for High Needs no news on years 2 or 3
- No clear detail yet of what additional cost pressures will need to be found from within this new funding i.e. inflation, rising secondary population, starting teachers salary = £30k
- A firm commitment to move towards a hard NFF but no news on when
- 2020-21 remains a Soft NFF year with "hardening" features

DfE have launched a consultation on how the mandating of MfL factor into the Local Funding Formula is implemented—closing date for responses is 22 October



2020-21 Spending Round Statement

Other key points from the announcement

- NFF core factor values to increase by 4% (except FSM 1.84%)
- MFG can only be set between +0.5% and +1.84%
- Local Authorities can continue to transfer funding into the High Needs Block – normal rules apply
 - Up to 0.5% with Forum approval
 - Above 0.5% (or below without Forum approval) requires SofS approval
- Confirmation that the additional costs associated with Teachers Pension will be separately funded at £1.5bn per annum, but silent on where Teachers Pay Grant will be funded
- Both Teachers Pension and Teachers Pay will continue to be paid as separate grants in 2020-21



2020-21 Spending Round Statement

Other key points from the announcement Post 16 specific

- Post 16 National Funding Formula base rate for 16 & 17 year olds to increase by 4.7% from £4,000 per pupil to £4,188
- Other elements linked to the base rate also set to increase
- Post 16 increases apply from the start of the 2020-21 academic year
- £120m additional funding to support higher value courses (STEM) via the Programme Weighting Factor
- £35m for targeted interventions to support Level 3 students who secured grades below level 4 in GCSE English and maths

Early Years

 Confirmed £66m additional funding for 2020-21. Confirmed hourly rate will increase but no further details



High Needs

- Confirmed that our share of the £780m will be £16m (8% increase for floor funded authorities). Some OLA +17%
- Reminder of current year figures

 Still going to be a significant in year overspend, let alone the accumulated deficit which we estimate to be in the region of £22m at the end of this financial year (£6.5m brought forward plus £16m in year overspend)



School Block 2020-21

Kent's Share

- Indicative DSG funding to be confirmed later in October
- Our estimate is an increase to our Schools Block of £52m (which equates to +5.7%), based on the following assumptions
 - Previous NFF rates increased by 4% except FSM which is to increase by 1.84%
 - Minimum Funding Levels of £3,750 for Primary and £5,000 for Secondary
 - No cap
 - Using 2019-20 school data from October 2018 census

Estimated increase	£52m
Estimated 2020-21 Schools Block	£970m



Consultation Proposals (LIVE 14 OCTOBER)

- All school consultation required on any changes to the Local Funding Formula
- List of issues to consult upon (in no particular order) . . .
 - General Principle continue to move towards NFF and take into consideration areas of local concern or full steam ahead to the NFF?

Areas of Local Concern

- 2. Continue to protect small primary schools by keeping lump sum at £120k (before ACA) all the time we have the ability? We could lower the lump sum for secondary schools to NFF rate?
- 3. Whether we should transfer any funding into the High Needs block? KCC are proposing to repeat the 1%.
- 4. Whether we introduce a Falling Roll fund



Consultation Proposals

Increasing the factor rates

- 5. Minimum Funding Levels should we set at NFF rates or something lower?
- 6. Replicate NFF increases (most +4%) to all LFF formula factors?
- 7. Funding of areas of local concern who pays?
 - Two scenarios modelled and impact illustrated, one pays MFL at full rate, other £50 reduction to the MFL (both phases).

Other issues

- 5. Introduce mobility factor? (in line with NFF new for 2020)
- 6. What level should we set the MFG at? (between +0.5% and 1.84%). KCC favours 0.5%
