BACS File Type for HSBC Customers in FMS6

A new BACS File Type has been added for HSBC bank customers.

The format of this new file has been verified with HSBC using dummy data. Schools are strongly advised to create a test BACS file from their FMS6 database and share it with their bank. This will enable them to confirm whether they can process your file appropriately.

FMS Release 6.196 will be made available to schools by EIS after Christmas. Any school that requires access to the upgrade sooner should contact EIS directly. This is required to be able to run HSBC BACS via FMS.

Schools Financial Services provide a chargeable remote service to support with the setup of online payments using FMS6. Please contact the helpdesk on 03000 415 415 to request further details.

PE & Sports Premium Funding

This year, the Government allowed unspent Sports funding from the 2019-20 academic year to be carried forward into the 2020-21 academic year due to Covid-19.

This is the funding that would have been received in November 2019 and May 2020 and must all be spent by 31st March 2021.

A reminder that the first instalment of the 2020-21 academic year will be funded in November 2020, and whilst this may be carried forward into the new financial year in April 2021, it is not one of the allowable criteria to be over the BCM.
