For all Kent Schools in the Corporate Banking scheme, without access to Bankline, Schools Financial Services will be producing a copy of their bank statement. This will be e-mailed to the School Finance Contact week commencing 15th March which can be used for 2020/21 Closedown. If you require a bank statement and haven't received one by 12 noon on 17 March 2021, then please contact us and we'll be able to produce this for you.

Those schools with Bankline or who are not in the corporate scheme should follow the guidance provided in the Closedown pack with regards to reconciling transactions up to 23 March 2021.

### **Budget Setting**

The deadline for the submission of the 3 Year Budget Forecast is Monday 31 May.
